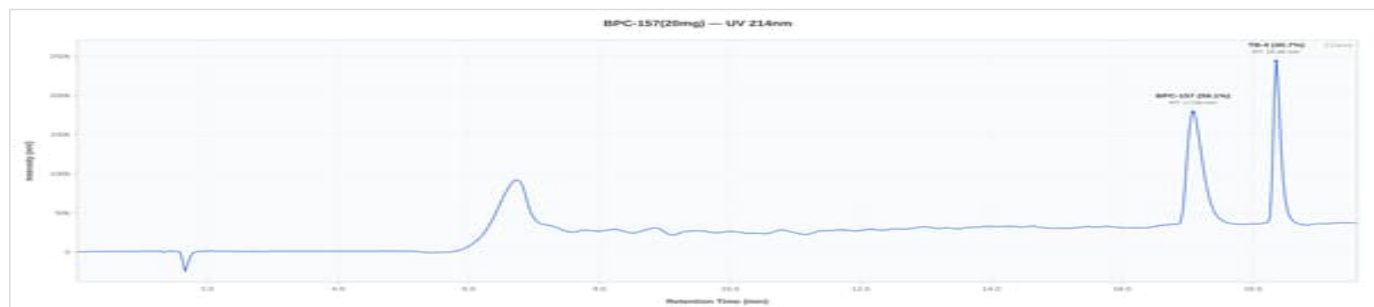

Notes & Methodology

1. Date Tested: 08/17/2026. Methods: Blend Purity, Identity & Quantitation (HPLC); Additional Tests.
2. The sample was confirmed to be Wolverine (BPC/TB) by HPLC. Identification by chromatographic retention time comparison with a reference standard.
3. Elemental impurities analyzed by ICP-MS per USP <233> methodology. Acceptance criteria are internal laboratory quality screening limits for research-use materials and do not represent evaluation against any specific pharmacopeial monograph or product specification.
4. Endotoxin tested per USP <85> kinetic chromogenic method. Acceptance criteria per client specification.
5. Peptide purity determined by RP-HPLC area normalization at 214 nm. Value represents the percentage of the target peptide relative to all peptide-related peaks. Non-peptide process-related impurities, if detected, are excluded from the calculation.
6. Per-component content calculated from total net peptide content using the manufacturer's stated formulation ratio (BPC-157, TB-500). All components confirmed present by HPLC identity testing, unless explicitly stated otherwise.
7. Chromatogram shown is representative: Conformity V1 (99.70% purity, closest to batch mean of 99.72%).
